## TERMS AND CONDITIONS

1. Mid America Equine Sales, LLC and its associates act as agent only on all sales, and are not responsible for buyer/seller error or misunderstanding.
2. Consignment forms must be accompanied by original registration papers and a signed transfer OR entry fee and a photocopy of the registration papers.
3. If entry is for Purina's Select Gelding Session, it must meet the following requirements: a) must be at least 3 years old, b) must be "broke to ride", which means reasonably safe and ready to ride, and entry **MUST** be rode through sale ring, c) must be guaranteed sound of mind and body, d) must not have any vices (i.e., cribbing, stall weaving, kicking, biting, etc). All consignors **must send a video** of potential entry to the Purina's Select Gelding Session (unless gelding has a performance record).
4. Individual **NEGATIVE COGGINS TEST** (original – not faxes or copies) **current within 6 months** and a Health Certificate **current within 30 days** must be provided day of sale.
5. A signed breeder's certificate must accompany all mares with foals on their side. Foal must be kept in the same stall as the mare or will be charged a separate catalog fee. Foal must be halter broke.
6. Mares selling in foal must have a completed and signed breeder's certificate OR a letter of guarantee from the stallion owner stating the breeder's certificate will be issued at time of foaling.
7. Any defects or bad habits must be called when horse is presented in sale's ring. (Example: Cryptoids, Cribbers, Lameness or Unsoundness, Parrot Mouth, HYPP N/H or H/H, etc.).
8. Consignors will be paid within 10 banking days from day of sale.
9. CATALOG FEE - \$250 (paragraph style catalog). Commission is 8% of the selling price. No Sales or Pass Outs must be stated before the horse leaves the sale's ring. Pass out fee is \$100.
10. The Catalog Fee is non-refundable. Consignor agrees not to withdraw entry except for serious injury, sickness or death, and will furnish sales company with a notarized veterinary statement prior to day of sale. The Consignor of any horse withdrawn from sale, for any reason other than serious injury, sickness, or death, will be assessed a \$500 penalty **IN ADDITION** to the Entry Fee or 8% of the selling price, whichever is greater.
11. Upon execution of this contract, Consignor agrees not to sell the horse by private sale. All horses must go through the sale's ring. **NO** horses are to be sold prior to going to the sale's ring. (NO trading out back).
12. A \$6.00 halter charge will be deducted for every horse sold. A new halter will be given to the buyer when payment is made.
13. Transfer fees for all AQHA horses will be deducted from seller.
14. Only horses that are consigned to the sale will be allowed on the sale grounds. All other horses sold before, during, and after sale will be subject to 8% commission and an entry fee.
15. All horses are subject to a selection process.
